



NORTHWEST ENERGY EFFICIENT ENERGY STAR® MANUFACTURED HOME PROGRAM (NEEM)

Eligibility: This Bonneville Power Administration (BPA) program is available to owners of new NEEM certified Energy Star manufactured homes that have an electric heating system. The home must be sited within Central Electric Cooperative, Inc. (CEC) service territory. Note: *BPA programs are subject to change without notice.*

1. Purchase a certified NEEM Energy Star Manufactured home.
2. Submit the completed Rebate Application form (on the back of this page) with the Energy Star Certificate of Compliance to CEC. The Energy Star certificate is typically enclosed with the paperwork that is shipped with the home to the site.
3. Once the certification for the home has been verified, a rebate check* will be issued to the Owner listed on the application.

Procedure:

1. Purchase a NEEM certified Energy Star manufactured home.
2. Complete the rebate application and submit it, along with the home's NEEM Energy Star Certificate of Compliance, to CEC Energy Star Home Program, P.O. Box 846, Redmond, OR 97756. The certificate is typically enclosed with the paperwork that is shipped with the home to the site.
3. Once the certification for the home has been verified, a rebate check will be issued to the Owner's name and address listed below.
